

## PRO BONO SPRING BREAK 2025 LEGAL AID ORGANIZATIONS



ABA The South Texas Pro Bono Asylum Representation Project (ProBAR) This is an inperson opportunity on the US-Mexico border with a nationally recognized nonprofit law firm providing direct assistance to migrants and asylum seekers. You will receive training and help individuals complete their work permit applications. With your involvement, individuals will be able to work in the United States and receive their Social Security card in under a month which is about 90% faster than normal. You will also have an opportunity to visit the border wall in Brownsville, Texas. See ProBAR's YouTube page for a brief video detailing the clinic. Bilingual, bring own devices.

Week: 2 Harlingen: In-person



American Gateways (AG) is a nonprofit organization that provides immigration legal services and education to families in Central Texas. AG's numerous programs provide assistance to the Central Texas immigrant community in the form of legal orientation and representation for asylum seekers detained in the following detention centers: Hutto, Karnes, and the South Texas ICE Processing Center (STIPC). AG also represents affirmative asylum seekers; persons applying for immigration benefits on the basis of being victims of crimes and human trafficking; family reunification; and naturalization (citizenship). Austin-based interns may work with the Hutto detention center. Supervised by attorneys, interns will work on individual cases in the various program areas. They may also be involved in removal (deportation) defense, including assisting with case research and documentation of claims for asylum and other relief from removal. English & Spanish required, bring own devices.

**Dallas Volunteer Attorney Program (DVAP)** provides free, civil legal help to low-income people in Dallas County. PBSB participants will assist with drafting case summaries, observing case staffing, assisting with Continuing Legal Education programs and recruiting events, and assisting with intake and interviews at various virtual legal clinics. English/Spanish preferred, but not required, bring own devices.

Week: 1 and 2 Dallas: In-person



Catholic Charities Dallas a faith-based social service agency focused on improving the quality of life for people in need. CC-Dallas serves as some of the first responders to the community's most vulnerable, helping those in crisis move toward a better life. Immigration Legal Services work may include but will not be limited to helping clients with Family Visa petitions, Adjustment of status applications, Consular Visa Processing, Representation of survivors of domestic violence/victims of violent crimes, Representation of minors and adults in removal proceedings, drafting motions for immigration hearings, Naturalization/Citizenship applications, Applications for Deferred Action for Childhood Arrivals, Permanent resident applications for refugees and asylees, and/or Document renewals and replacements. English/Spanish preferred, bring own devices.

**Disability Rights of Texas (DRT)** advocates for and protects the rights of individuals with disabilities and handles special education cases for K-12 students who have disabilities, including special education cases involving foster children and other students in psychiatric facilities. In addition to special education issues, students may possibly assist with other teams such as Community Integration/Healthcare, Social Security Rep. Payee, and HEAT (Housing, Employment, Accessibility, and Transportation). Students will likely participate in projects such as drafting federal administrative complaints, research of legal issues, and interaction with clients. English/Spanish preferred but not required. Bring own devices.

The Earl Carl Institute for Legal & Social Policy Inc Under the supervision of an ECI attorney, students may be asked to conduct legal research, assist with preparation for hearings, prepare legal documents, and assist with community education and outreach. This Week 2 opportunity is preferably in person. Our focus areas include property preservation (foreclosure defense, eviction defense and other landlord-tenant issues, title clearing, probate, and estate planning); juvenile justice (representation and advocacy in school disciplinary proceedings, delinquency court, and emancipation proceedings); criminal record clearing; citizenship by naturalization; and working with the Texas Southern University Innocence Project. The Earl Carl Institute is dedicated to identifying potential implementable solutions to legal and social issues disproportionately impacting communities of color and other disenfranchised populations. The mission of the Institute is to empower underserved and disenfranchised communities by addressing systemic social issues through legal representation, research, education, and advocacy.

The work will range from assisting with intakes, evidence collection and compilation, legal research, and compiling country condition reports in support of asylum seeker claims. For those students who participate in-person, there may be an opportunity to assist newly arrived asylum seekers with completing work permit applications at one of the migrant shelters we provide services at. All appointments are completed over the phone and staff meet in the office once a week as needed.

**Texas Fair Defense Project (TFDP)** fights to end the criminalization of poverty in Texas using advocacy, education, litigation, and community lawyering. Provides legal services to people struggling with paying ticket and court debt, who have driver's license suspensions, or who have outstanding warrants. Internet access and computer.

Week: 1 and 2 Remote Only



**TEXAS ADVOCACY PROJECT** is a statewide agency, TAP works to prevent domestic and dating violence, sexual assault, stalking, and human trafficking through advice and counsel via our legal hotline, assistance in pro se matters, and court, or direct, representation. Pro se assistance includes help with divorce, child custody, and all types of protective orders. In collaboration with our social work department, TAP also assists with power-based abuse cases involving civil legal matters such as housing, employment, education, and immigration. TAP offers students the opportunity to interact with each aspect of the civil system and to become educated about the dynamics of abuse through legal research, document preparation, client interaction, and internal training. Dual language (not required), bring your own devices.

Week: 1 and 2 Remote Only



The Texas Legal Services Center Medical Legal Partnership is a civil legal aid model that positions services within healthcare settings to help people with legal problems be better able to access mental and physical care. The healthcare settings that our office serves include People's Community Clinic, CommUnity Care Southeast, Kind clinic, and Austin and Cedar Park VA clinics. Most of the referrals we receive involve housing issues, family law matters, and assistance with government benefits but include a wide range of legal services.

Week: 2 Remote Only



Lone Star Legal Aid is a civil legal services provider, and provides free advocacy, legal representation, and community education that ensures equal access to justice in 76 counties. Under attorney supervision, students may assist with legal and factual research, attend client outreach or educational events, and/or assist with an attorney with preparing legal documents and/or provide support for legal matters. Some of the civil legal matters involve, but are not limited to, consumer issues, family law, probate & probate alternatives, and estate planning. Clients include survivors of domestic violence or sexual assault, veterans and their family, and immigrant households. Student will need to bring own device.

Week: 1 & 2 Houston: In-person
